The Project substation will be located south and slightly east of the intersection of 75th Ave NW and Acorn Rd NW and the MN Power substation will be north of the Project substation at the intersection of those roads. I have attached a more detailed map that will be included in the Addendum application to the PUC to provide some clarity. Note the pink box labeled "switching station area" is where the MN Power substation would be located and the light blue triangle is the Project substation location. The exact location of the gen-tie to connect the facilities has not yet been determined so the navy hashed area represents the potential area where that gen-tie could be located.

All of the easements have been secured and the above-ground lines will be located on private property with the exception of approximately 650 feet of land owned by Benton County along Halfway Crossing and Regal will seek a Utility Crossing Agreement from the county. I understand Jordan has been in touch with Chris Byrd regarding this area (another map is attached showing this area for your reference).

Thank you for your time a few weeks ago to discuss the update to the Regal Solar Project. As we discussed, the Project's point of interconnection has been updated from the Platte River Substation to the Langola Tap following the completion of DPP1 by MISO and discussions with MN Power, GRE, and MISO. The Project substation will now be located east of the Langola Tap and the Project will interconnect to the substation via an above-ground 34.5 kV collection line. This modification required securing easements along a corridor to accommodate this change (see attached map). Regal is in the process of drafting an amendment to the MN PUC Site Permit Application to reflect this update and we anticipate filing before the end of the month.
