Dear Mr. Seuffert:

Since Regal Solar, LLC ("Regal") filed its Revised Application for a Site Permit for the up to 100 MW Regal Solar Project in Benton County, Minnesota on September 6, 2019 ("Revised Application"), Midcontinent Independent System Operator ("MISO") completed the first phase of transmission interconnection studies ("DPP1") for the above referenced Project. Upon completion of DPP1, MISO and the owners of local distribution and transmission lines indicated to Regal they had concerns about the potential impact of the Project on the local distribution system and the 115 kV line tap to which the Project was planned to interconnect.

To avoid potential problems on the 115 kV line tap and the local distribution system, Regal and the utilities agreed that Regal would revise its interconnection application with MISO to interconnect at a new Minnesota Power switching station that would connect to the existing 115 kV line that runs between Little Falls and St. Cloud near the Langola Tap. The modification includes shifting the Project substation from the existing proposed location to a location at the southeast intersection of the two 115 kV lines near the Langola Tap. The Project would interconnect to the Project substation via an approximately 3.3-mile-long double-circuit aboveground 3-phase 34.5 kV collection line.

Regal alerted Department of Commerce Environmental Review and Analysis ("EERA") staff, Administrative Law Judge Palmer-Denig, and Public Utilities Commission ("Commission") staff of this change at a status conference for the previously scheduled public hearing and requested additional time to update the record to reflect the change in the point of interconnection. Since that time, Regal has worked with EERA staff to provide the attached Addendum to the Revised

Application. The Addendum describes the updates to the Project description, engineering and operational design, environmental information, and agency and public outreach sections. Every section of the Revised Application is included in this Addendum; each section includes updated information and analysis, as necessary, or a statement that there is no change from the Revised Application. New information presented in this Addendum is intended to be a supplement to the Revised Application.

The Addendum is being submitted on behalf of Regal and has been efiled through www.edockets.state.mn.us. Regal will send a copy of the Addendum to any regional development commission, county, incorporated municipality, and town in which any part of the Project is proposed. Regal will also send a notice of the Addendum and a description of the Project to each owner whose property is on or adjacent to the proposed site, including the collection line corridor.
