Pursuant to Minnesota Statutes Chapter 216F and Minnesota Rules Chapter 7854, Dodge County Wind, LLC ("DCW") respectfully submits its amended Application for a Site Permit ("Amended Site Permit Application") to build up to a 259 MW Large Wind Energy Conversion System and associated facilities in Dodge and Steele Counties, Minnesota. This application is intended to amend and update the initial application filed on September 14, 2021 in this docket.

The Amended Site Permit Application has been submitted via the Minnesota Public Utilities Commission's e-filing system and hard copies of the Application are being provided to the Minnesota Department of Commerce.

The Amended Site Permit Application has been revised and resubmitted to reflect:

- Updated sound modeling based on General Electric's ("GE") latest sound modeling simulations, which were provided by GE after DCW filed its original application; and
- Three turbines will utilize noise reduction operation software to ensure compliance with sound level requirements.
