PROJECT DESCRIPTION

The Line 3 Replacement Project proposed by Enbridge Energy, Limited Partnership is described as a new 337-mile long, 36-inch diameter pipeline that would replace 282 miles of the existing 34-inch Line 3 pipeline in Minnesota. The pipeline route proposed by Enbridge would parallel the route of the existing Line 3 pipeline from the North Dakota-Minnesota border to Clearbrook, Minnesota, but would require a new right-of-way from Clearbrook to Superior, Wisconsin. The existing Line 3 pipeline is proposed to be permanently deactivated and left in-place after the new pipeline is installed, tested, and operational. Associated facilities would include eight pumping stations, valves, metering and monitoring equipment, and related electrical facilities. Enbridge's proposed pipeline route would cross portions of Kittson, Marshall, Pennington, Polk, Red Lake, Clearwater, Hubbard, Wadena, Cass, Crow Wing, Aitkin, and Carlton counties.

PUBLIC HEARING INFORMATION

The purpose of the public hearing is to compile a full record for the Commission to consider in making a final decision on the Line 3 Project certificate of need and route permit applications.

The hearing will be conducted by an ALJ in accordance with Minnesota Statutes, sections 14.57 to 14.62; Minnesota Rules, parts 1405.0200 to 1405.2800; and, to the extent they are not superseded, Minnesota Rules, parts 7829.0100 to 7829.3200. The applicable statutes and rules are available at: revisor.mn.gov.

Members of the public may participate without the necessity of intervening as a party. Representation by legal counsel is permitted but not required. Citizens will have the opportunity to question witnesses and offer oral and written comments into the record at the hearing. The hearings will end upon the final speaker. Please arrive promptly to be heard. If the final speaker is heard prior to the scheduled end time, the hearing will adjourn. The ALJ may elect to recess the hearing and set additional days for hearing, if necessary.
