4 My message is that the Line 3
5 replacement project needs to change its method of
6 decommissioning to require Enbridge to take the pipe
7 out when they put the new one in.

8 I feel that the minimum standards of
9 federal guidelines are inadequate for Minnesota and
10 eventually that pipe is going to leak. It's going
11 to rot away and leak, even with cathodic protection
12 and monitoring. It may be awhile, but that pipe
13 will rot away and what's ever inside or what it's
14 made up of will be in the ground.

15 And I think the need of pipelines is
16 strong. We just need to make it safer and better
17 for the environment and people of Minnesota.
