Dear Mr. Seuffert:

Three Waters Wind Farm, LLC (“Three Waters”) respectfully submits this filing to notify the Minnesota Public Utilities Commission (“Commission”) of a change in upstream ownership. On July 14, 2020, Twin Wind, LLC, a Delaware limited liability company and an indirect wholly-owned subsidiary of NextEra Energy Resources, LLC, acquired all the membership interests in Three Waters from Scout Clean Energy.

The new owner of Three Waters is currently evaluating the impact the change in control will have on the current Certificate of Need and Siting processes. Three Waters commits to provide the Commission, presiding Administrative Law Judge (“ALJ”), and all parties with an update within thirty 30 days. In the interim, Three Waters will coordinate with the presiding ALJ, Commission Staff, and the Department of Commerce to postpone the planned Public Hearing for later this month.
