**PLEASE TAKE NOTICE** that the Minnesota Public Utilities Commission (Commission) and the Department of Commerce (Department) will hold public information and environmental analysis (EA) scoping meetings on Great River Energy's (GRE) application for a route permit to construct approximately 6.3 miles of 115 kilovolt (kV) high-voltage transmission line (HVTL) to connect the Cedar Lake substation to GRE's MV-EVX 115-kV HVTL in Scott and Rice counties.

The purpose of the meeting is to: (1) provide information to the public about the proposed project and the state's high-voltage transmission line route permitting process; and (2) provide members of the public an opportunity to participate in developing the scope of the environmental assessment. This includes commenting on issues or concerns related to the proposed project and proposing alternatives for consideration. There will be two public meetings in this matter: an in-person meeting and a WebEx (online) meeting. The information presented will be the same at both meetings.

#### **Project Summary**

The Project is being done to make room for a second 345-kV circuit to be attached to the existing CapX2020 Brookings to Hampton transmission structures, which run along County Road 2 in the Project area. The Project will include construction of a new approximately 6.3-mile 115-kV transmission line. The transmission line will connect at GRE's existing MV-EVX 115-kV transmission line near the intersection of County Road 23 and Minnesota Highway 19 and extend to the existing Cedar Lake Substation south of County Road 2. The Project will initially operate at 69 kV; but will be designed to 115-kV standards to accommodate future load growth in the area. Once the transmission line is constructed and connected to the substation, GRE's existing 4.5-mile MV-CDT 115-kV transmission circuit, which is co-located in part on the CapX2020 345-kV transmission structures along County Road 2, will be removed.

The Commission accepted the route permit application as substantially complete on July 5, 2023.

#### **Route Permit Application Review Process**

Under the Power Plant Siting Act (Minn. Stat. ch. 216E), a route permit from the Commission is required to construct a high-voltage transmission line. The project will be reviewed under the alternative permitting process because it is a high-voltage transmission line between 100 and 200 kilovolts. The statutes (Minn. Stat. § 216E.04) and rules (Minn. R. 7850.2800 to 7850.3900) detailing the alternative permitting process may be viewed at: <a href="https://www.revisor.mn.gov">https://www.revisor.mn.gov</a>.

**Environmental Review.** The Minnesota Department of Commerce is tasked with preparing an environmental assessment for the Commission on high-voltage transmission line projects filed under the alternative permitting process. The environmental assessment will contain information on the human and environmental impacts of the proposed project and of any alternative routes identified. The environmental assessment will identify and address mitigating measures for all routes considered.

**Public Hearing.** When the environmental assessment is complete, a public hearing will be held in the project area. The hearing will be presided over by an administrative law judge from the Office of Administrative Hearings. At the hearing, members of the public will have an opportunity to make an oral presentation, present evidence, and ask questions of the applicant and staff.

Upon completion of the public hearing process, the Commission will make a final decision on whether to issue a route permit. If a route permit is issued by the Commission, it is possible that GRE may be able to exercise the power of eminent domain to acquire land for this project to the extent otherwise authorized by law.


