The Honorable Suzanne Todnem, Administrative Law Judge with the Office of Administrative Hearings, will administer the hearing and will provide the Commission with a report setting forth findings of fact, conclusions of law, and recommendations on the merits of the route permit application and provide recommendations, if any, on conditions and provisions for a route permit. The purpose of the public hearing is to obtain public input on the proposed project and compile the record for the Commission to consider in making a final decision on the route permit applications.

Project Description

On June 2, 2023, Great River Energy (GRE) filed a route permit application with the Minnesota Public Utilities Commission (Commission) to construct approximately 6.3 miles of 115-kilovolt (kV) high-voltage transmission line (HVTL) to connect the Cedar Lake substation to GRE's MV-EVX 115-kV HVTL in Scott and Rice counties. The project entails a reroute of approximately 4.5 miles of the existing MV-CDT 115-kV HVTL currently located on structures that were built for the CapX2020 Brookings County – Hampton 345-kV Project in Scott County. The replacement line will provide service to the Cedar Lake Substation but will initially operate at 69-kV.

The Project is being done to make room for a second 345-kV circuit to be attached to the existing CapX2020 Brookings to Hampton transmission structures, which run along County Road 2 in the

Project area. Once the transmission line is constructed and connected to the substation, GRE's existing 4.5- mile MV-CDT 115-kV transmission circuit, which is co-located in part on the CapX2020 345-kV transmission structures along County Road 2, will be removed.

Environmental Assessment

The Department has prepared and issued an environmental assessment (EA) for the proposed project. The EA analyzes the potential impacts of the proposed Project and possible mitigation measures and was issued on December 29, 2023. In addition, the EA analyzes the potential impacts of any alternatives (including route alternatives) contained in the scoping decision. The EA is available on the Department's website and on eDockets (see Additional Information, below). Public Hearing and Process Information

The public hearings and written comment period afford interested persons the opportunity to ask questions of the applicant and agency staff and to offer oral and written comments on the merits of the proposed project, on the EA, and on conditions to be considered for inclusion in a route permit.

Written comments will be accepted through **February 7, 2024**, by 4:30 p.m. Please include both docket numbers in all communications. Comments received after the close of the comment period may or may not be considered by the Commission.

Please focus your comments on information that will help answer the following questions:

- Should the Commission grant a route permit for the proposed project?
- What are the human and environmental impacts of the project, and how can these impacts be addressed and mitigated in the route permit?

- What are the environmental and human impacts of the proposed project and how can these impacts be addressed?
- If a route permit is granted for the facility, which route alternative and alignment modifications should be selected?
- If a route permit is granted for the facility, what additional conditions or requirements should be included?
- Are there other project-related issues or concerns?
