# In the Matter of the Application of Snowshoe BESS, LLC for a Site Permit for the up to 150 MW Snowshoe Energy Storage Project in Olmstead County, Minnesota.

**PLEASE TAKE NOTICE** that the Minnesota Public Utilities Commission (Commission) and Minnesota Department of Commerce (Commerce) will hold public information and environmental assessment scoping meetings on Snowshoe BESS, LLC's (applicant) site permit application for a battery energy storage system (BESS) with a nominal power rating of up to 150 megawatts (MW) alternating current (AC) with approximately 600 megawatt-hours (MWh) of energy capacity in Kalmar Township, Olmsted County, Minnesota. (see attached map).

In addition to battery energy storage enclosures, the Project will consist of inverters and transformers, electrical feeder lines, a tap line, a substation, storage and parking areas, access roads, fencing, and other minor equipment and subcomponents as are typical of a BESS project. Snowshoe BESS may construct an operations and maintenance (O&M) facility at the site or may lease existing space nearby for an O&M facility.


