**PLEASE TAKE NOTICE** that the Minnesota Public Utilities Commission (Commission) will hold public hearings on the applications of Benton Solar LLC for site and route permits for the proposed Benton Solar Project, including an up to 100 megawatt alternating current (MWac) solar energy generating system, a 100 MWac battery energy storage system (BESS), and a route permit for a new approximately 0.5-mile 115-kilovolt (kV) transmission line. The application was filed with the Commission on September 24, 2024.

The proposed project is located on approximately 632 acres of private land on a 951.4-acre project site located 4.0 miles east of St. Cloud in Minden Township, Benton County, Minnesota. The main components of the project include, but are not limited to, solar modules and tracking systems, electrical collector lines, inverters, transformers, battery energy storage systems, a project substation, security fencing, access roads, stormwater basins, an operation and maintenance building, and weather stations.

Benton Solar has identified the existing Great River Energy (GRE) Benton County Substation as the point of interconnection (POI) for the Project and has proposed to build a 0.5 mile long 115-kV transmission line to deliver the energy from the Project to the electrical grid. A Project Overview Map is included below.

The Applicant indicated it has secured a Generator Interconnection Agreement as of December 7, 2022, to connect the Project to the grid at GRE's Benton County Substation and is working toward securing an agreement related to the sale of power generated by the Project. Construction is anticipated to begin in Q2 of 2026 and commercial operation in Q4 of 2027.

### **Environmental Assessment**

The Commission issued an environmental assessment (EA) for the project on July 24, 2025. The purpose of the EA is to provide information on the potential human and environmental impacts of the proposed project, and possible mitigations for identified impacts. ### **Public Hearing Information**

The public hearings will be presided over by the Honorable Megan McKenzie, an administrative law judge from the Office of Administrative Hearings, who will provide the Commission with a report including findings of fact, conclusions of law, and a recommendation.

The purpose of the public hearings is to obtain public input on the proposed project and compile the record for the Commission to consider in making a final decision on the site and route permit applications. Specifically, interested persons will have the opportunity to: (1) ask questions of state staff and the applicant; (2) offer oral and written comments on the merits of the proposed project and on the environmental assessment; and (3) suggest possible conditions to be considered for inclusion in the site and route permits.

- Comments received at the hearings and during the comment period will be used to inform the record and help the Commission make its final decision.
- The information presented will be the same at all in-person and online hearings.
- The hearings will end when all attendees have had the opportunity to comment and all other business has been concluded, or the scheduled end time of the hearing, whichever occurs first.
- Members of the public may participate without the necessity of intervening as a party; representation by legal counsel is permitted but not required.

Written comments will be accepted through **September 12, by 4:30 p.m.** Please include the docket number in all communications. Comments received after the close of the comment period may or may not be considered by the Commission.

### **Topics for Comment**

- *Should the Commission grant site permits for the proposed solar energy generating system and the battery energy storage system?*

- *Should the Commission issue a route permit for the transmission line associated with the solar and battery energy storage project?*
- *If granted, what additional conditions or requirements should be included in the site permits and/or in the route permit?*

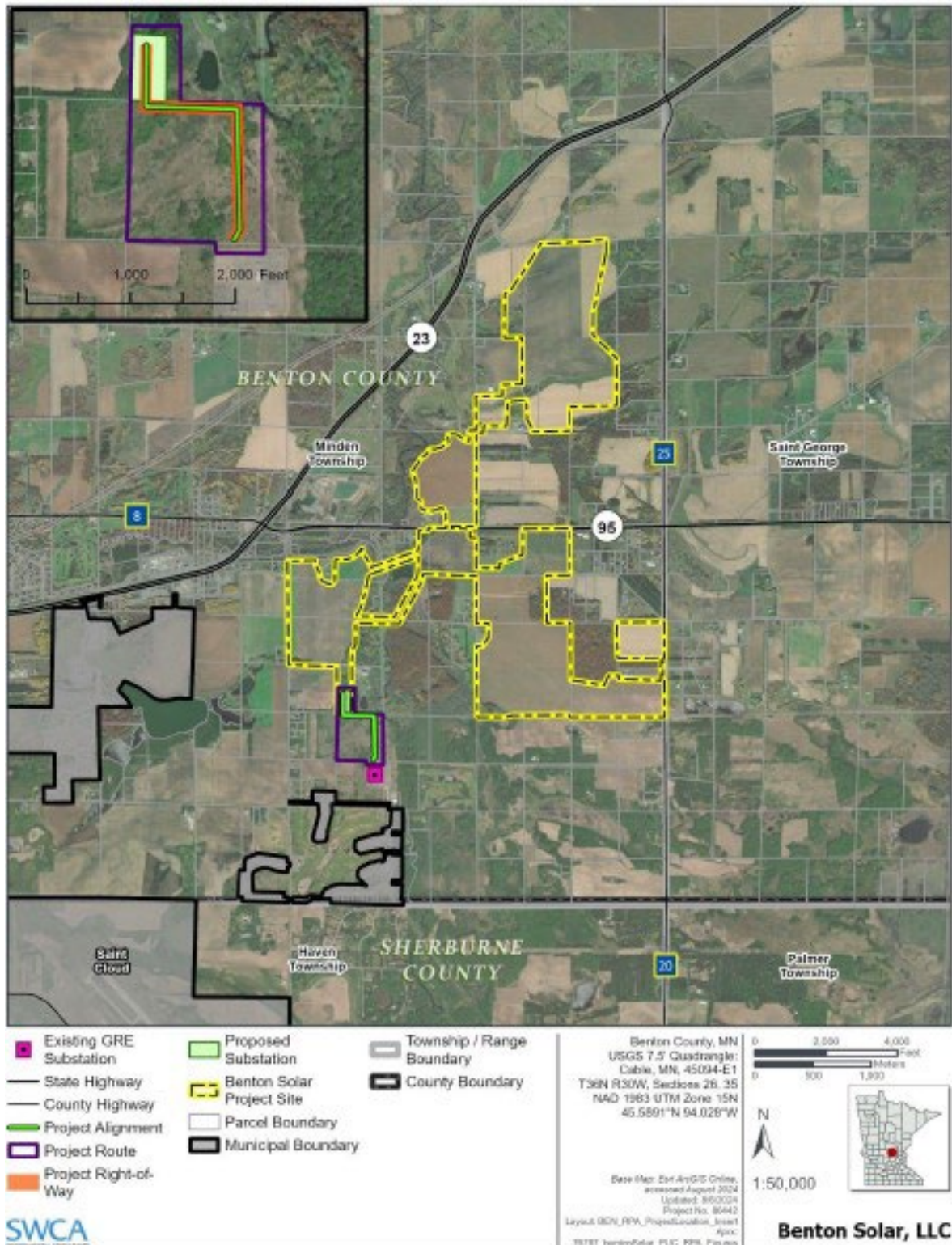
