

**NOTICE OF PUBLIC INFORMATION AND
ENVIRONMENTAL ASSESSMENT SCOPING MEETINGS**

In the Matter of Lake Charlotte Solar, LLC's joint application for the Lake Charlotte 150-MW Solar Facility and 150-MW Lake Charlotte Battery Energy Storage System (BESS) located in Rutland Township, Martin County, Minnesota

PLEASE TAKE NOTICE that the Minnesota Public Utilities Commission (Commission) will hold public information and environmental assessment (EA) scoping meetings on the joint site permit application of Lake Charlotte Solar, LLC (Lake Charlotte Solar), a wholly owned subsidiary of Geronimo Power, LLC (formally known as National Grid Renewables Development, LLC) to construct and operate an up to 150-megawatt (MW) alternating current (AC) nameplate capacity solar energy conversion facility (Solar Facility), an associated 150 MWac/600-megawatt hour (MWh) battery energy storage system (BESS) (BESS Facility), and other associated facilities located in Martin County, Minnesota (the Lake Charlotte Solar and BESS Project, or Project).

The Project is located in Rutland Township in Martin County, Minnesota. The Project footprint is approximately 1,277 acres, of which approximately 1,004 acres will be used for the operation of the Project.

The Project will include: solar modules (also referred to as panels or arrays); inverters; transformers; a tracking rack system; an electrical collection system; access roads; security fencing; security cameras and lighting; a collector substation; an operations and maintenance building; parking; stormwater retention ponds; weather stations; temporary laydown areas, a 161 kilovolt (kV) transmission generation tie-line; BESS Facility and associated equipment; and any ancillary equipment or buildings as necessary and typical of a solar farm. (See the attached Project Overview Map).

Lake Charlotte Solar has identified the existing Southern Minnesota Municipal Power Agency (SMMPA) Rutland Substation as the point of interconnection (POI) for the Project via an above ground 161 kV gen-tie transmission line of approximately 366 feet long to deliver the energy from the Project to the electrical grid.

Lake Charlotte Solar has an executed Generator Interconnection Agreement with SMPA and Midcontinent Independent System Operator, Inc (MISO) and is working to secure a Power Purchase Agreement, Build Transfer Agreement, Development Transfer Agreement, or other enforceable offtake agreements to sell the electricity, Renewable Energy Certificates, and capacity generated or stored by the Project. Construction is anticipated to begin in the third quarter of 2027 with a targeted completion in the fourth quarter of 2028.

Following the presentations, attendees will have the opportunity to offer oral and written comments for the record. ***The meetings will end when all attendees have had the opportunity to comment and all other business has been concluded, or the scheduled end time of the meeting, whichever occurs first.*** The information presented will be the same at all in-person and online meetings.

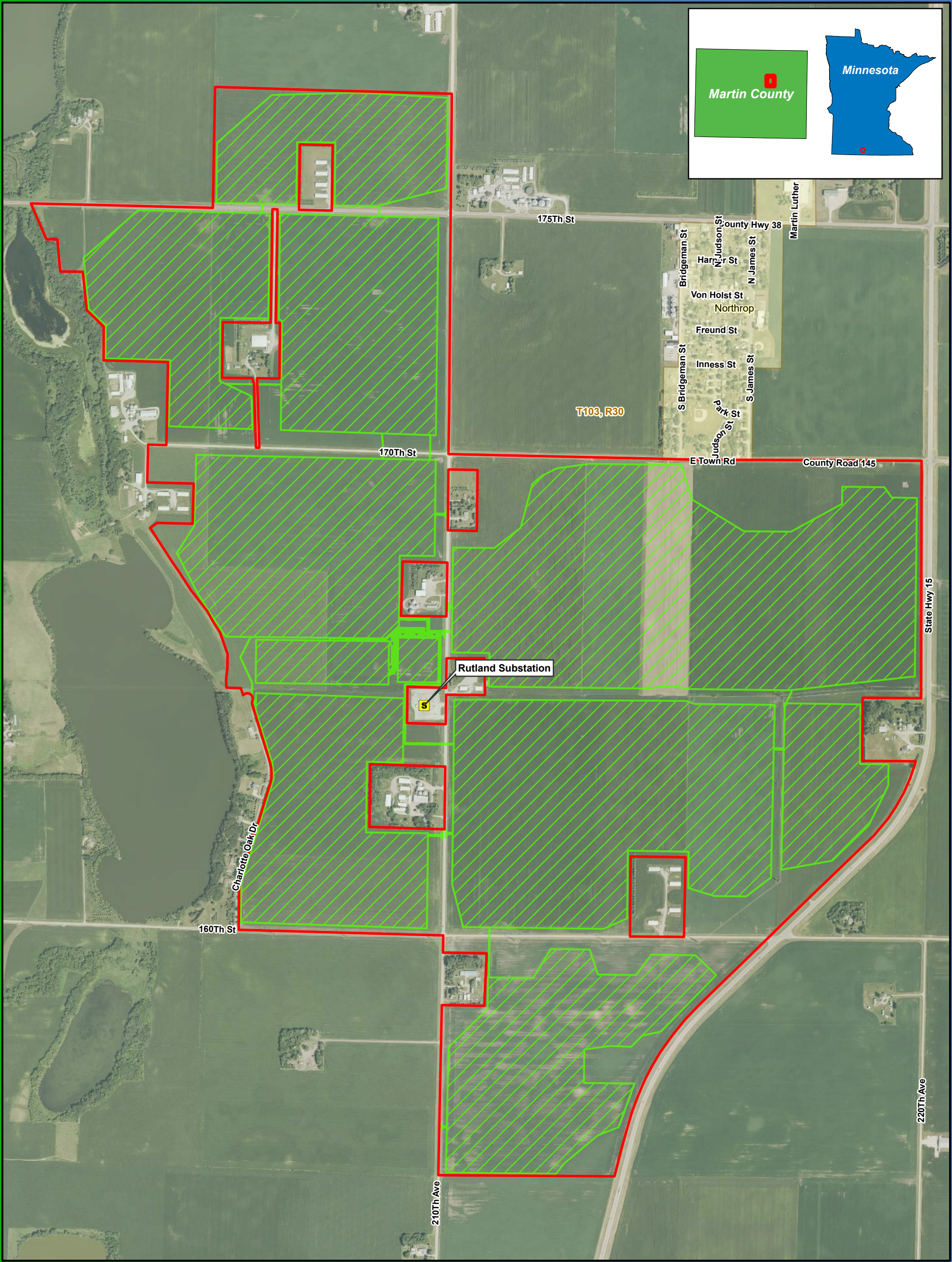
