The Project is designed for operation at a capacity of over 50 MW and thus is subject to the Minnesota Public Utility Commission's (Commission's) siting authority jurisdiction. Therefore, Benton will seek a Site Permit from the Commission under Minnesota Statutes Section 216E.04 (Subdivision 2(8)), and Minnesota Rules 7850.2800 – 7850.3900.

The Project will be situated within an approximately 3,077.3-acre Project area located in Township (T) 36 North (N), Range (R) 29 West (W), Sections 7, 18, 19 and 30; and T36 N, R30 W, Sections 12-14, 23-26, and 34-36. The Project site plan has not been finalized at this time; however, the Project is likely to include the following facilities:

- Solar panels/modules
- Gravel access roads
- Inverters
- Underground collection lines
- Security fencing
- An operations and maintenance building
- A substation

The Project also will include an associated generation-tie line (gen-tie). Benton anticipates that the gen-tie will meet the relevant definition of a high-voltage transmission line in Minnesota Statutes Section 216E.01 (Subdivision 4). Therefore, Benton anticipates seeking a Route Permit from the Commission and intends to prepare a standalone Route Permit application. Benton will provide you with separate correspondence describing the gen-tie and requesting your associated comments.

To facilitate your review of the Project, we have enclosed a figure and corresponding shapefiles depicting the Project area. Project facilities will occupy only a portion of the Project area.



We (Lands and Minerals Division) are not accustomed to being asked for a general review of an entire project. We do reviews when we get an application for a utility crossing license crossing for specific state lands and public waters. We process and approve that application and issue a license.

We cannot sink much time into a resource and technical review process until we have an application in front of us.

Also, there is not enough or the right type of information to allow us to pre-review the proposal as provided. There is no information on where the infrastructure is going to be or how power will be routed off the site, therefore, I don't know if you will need to apply for utility crossing licenses or not.

I am attaching a map that reflects the outline of the 3,000-plus acres you are indicating as the project area, along with an overlay three public watercourses within the area, and one or two lakes. If there are crossings of any of these watercourses, utility licenses will be required.





Good morning Brittney. This was sent my way for prelim BWSR comments on your proposed solar project. My role is specific to areas of the project that may affect/impact wetlands under the Wetland Conservation Act (WCA-MR 8420). WCA is a locally administered rule (Benton County Dept of Development). I am involved via the Technical Evaluation Panel (TEP) along with LGU, DNR, and SWCD staff. My comment would be to recommend a wetland delineation be completed for those areas proposed (or considered) for placement of any roads, infrastructure, panels or other areas that may be disturbed. This will assist you in planning efforts and avoidance of wetland impacts to the extent possible.

Often times at this phase you could consider a level 1 delineation for planning purposes, but will

need to conduct a level 2 (onsite) delineation prior to finalization. A wetland consultant can also help you decide which options work for you at this phase.

At first glance and understanding that the physical project boundary will not encompass MnDOT TH 95 right-of way, below are initial comments on the project:

- 1. Areas of TH 23 where MnDOT looks to have right-of-way extending into the project area will need to be cross-referenced thoroughly and adjusted as needed.
- 2. MnDOT OES map layer shows 1 contaminated site within and 2 additional MPCA sites at the project boundary (65<sup>th</sup> Ave north of TH 95 and 55<sup>th</sup> Ave south of TH 95). These findings will likely be covered during your work with MPCA.
- 3. MnDOT OES map layer shows your project boundary overlapping a Cultural Resources Unit Historically Sensitive Area (no further details can be provided). These findings will likely be covered during your work with SHPO.

- 4. When available, MnDOT is interested in viewing the project's collection system and associated facilities for review of their potential effects on TH 23 and TH 95.
